# A BILL

To direct the Director of the Office of Community Oriented Policing Services to carry out a pilot program to establish community outpost houses, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Community Outpost  
5 Outreach and Engagement Act”.

6 **SEC. 2. COP HOUSE PILOT PROGRAM.**

7 (a) **AUTHORIZATION.**—The Attorney General, acting  
8 through the Director of the Office of Community Oriented

1 Policing Services to carry out a pilot program to make  
2 grants to eligible applicant to establish and operate com-  
3 munity outpost houses (referred to in this section as  
4 “COP houses”).

5 (b) PURPOSE.—The purpose of the pilot program is  
6 to provide long-term stabilization in the relationship of law  
7 enforcement and the community by—

8 (1) building relationships, awareness, and trust  
9 with members of the community;

10 (2) uniting members of the community and law  
11 enforcement;

12 (3) improving the quality of life in the neigh-  
13 borhood; and

14 (4) reducing crime.

15 (c) USES OF FUNDS.—A COP house funded under  
16 this section may provide services, including—

17 (1) connecting with residents and involvement  
18 in community outreach programs;

19 (2) providing government benefit program con-  
20 sultations;

21 (3) nursing services and coordination with med-  
22 ical services in the community;

23 (4) emergency medical services;

24 (5) space for use by community groups; and

1           (6) holding events with community partners, in-  
2           cluding public health services, educational classes or  
3           seminars, tutoring services for youth.

4           (d) OFFICER QUALIFICATIONS.—A recipient of a  
5           grant under this section shall certify to the Director that  
6           any officer stationed at the COP house—

7           (1) has demonstrated their communication and  
8           problem-solving skills;

9           (2) does not have a history of verified instances  
10          of excessive force; and

11          (3) has completed necessary training to under-  
12          stand the cultural sensitivities of the obligations of  
13          a position at the COP house.

14          (e) REPORT.—The Director shall submit to Congress  
15          on an annual basis information related to the operation  
16          of the pilot program under this section, including the im-  
17          pact that COP houses have had on the relationships be-  
18          tween law enforcement officers and the community and  
19          any changes in the rates of crime in the communities in  
20          which COP houses have been established pursuant to this  
21          section.

22          (f) DEFINITIONS.—In this section:

23           (1) The term “eligible applicant” means a non-  
24           profit organization, or a law enforcement organiza-

1           tion applying jointly with at least one non-profit or-  
2           ganization.

3           (2) The term “community outpost house”  
4           means a location in the jurisdiction served by a law  
5           enforcement agency that is operated by the law en-  
6           forcement agency in a collaborative manner with  
7           nonprofit organizations and other service providers.
