Dear Mr. President:

Under the provisions of Section 401 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. §§ 5121-5207 (Stafford Act), as implemented by 44 CFR § 206.36, I request that you declare a major disaster for the State of Minnesota because of extensive fire damage to public infrastructure caused by civil unrest.

The death of Mr. George Floyd on May 25 sparked numerous peaceful protests across Minnesota. Beginning on May 27, individuals bent on destruction infiltrated otherwise peaceful protests and began to incite violence and vandalism, especially within our two largest cities of Minneapolis and Saint Paul. Initial damage estimates for this incident were well over \$100,000,000. While many areas suffered damage, Minneapolis bore the brunt of the destruction. Deliberately set fires were used to wantonly destroy local businesses, public buildings, and other property.

Nearly 1,500 businesses in the Twin Cities were damaged by vandalism, fire, or looting. The heaviest damage occurred along major corridors of commerce and public accommodation, including Lake Street in Minneapolis and in the Midway Area of Saint Paul. These corridors provide lifeline services like food, pharmaceuticals, health care, housing, and transportation to thousands of Minnesotans. Refined estimates of property damage are now upwards of \$500,000,000, making this the second most destructive incident of civil unrest in United States history after the 1992 Los Angeles riots. The social and economic impacts of this incident will be felt for years, if not decades.

The resources of local, tribal, county, and state governments were already stretched thin due to our ongoing response to the COVID-19 pandemic. However, all levels of government

MN Relay (800) 627-3529 An Equal Opportunity Employer surged available resources for immediate response to preserve life and safety and to protect property and infrastructure from additional damage.

The Minnesota emergency operations plan and our state emergency operations center were already fully activated to support the COVID-19 response, so we were able to quickly pivot to address the civil unrest while simultaneously maintaining our pandemic operations.

In response to the civil unrest, I ordered the full activation of the Minnesota National Guard for the first time since the beginning of World War II. The Minnesota State Patrol called in every available trooper to respond to the incident. These forces were joined by law enforcement officers from state agencies, county sheriff offices, police departments from across the state, and state troopers from Wisconsin. In the end, over 10,000 law enforcement officers, soldiers, airmen, firefighters, and emergency medical services professionals contributed to the effort to restore peace and safety to our streets.

In the aftermath of these unprecedented events, federal, state, and local law enforcement agencies are working cooperatively on criminal investigations. Federal charges have been filed against 10 people for rioting or arson during the unrest.

The Minnesota Division of Homeland Security and Emergency Management conducted a virtual preliminary damage assessment (PDA) jointly with staff from FEMA Region V during the week of June 23 and 26. This survey quantified the extent of debris removal, emergency protective measures, and damage to public buildings and equipment. The PDA verified \$15,658,865 of eligible damages directly related to the fires. That is nearly two times our statewide damage indicator of \$8,115,005. The PDA catalogued eligible damages in Public Assistance (PA) categories A, B, C and E.

Minnesota needs federal assistance to recover from these fire-related damages. We are still working on nine previous Stafford Act disasters. Minnesota is currently fully engaged with the coronavirus pandemic response and recovery under FEMA-4531-DR. Minnesota's two other most recent disasters, FEMA-4414-DR for storm surge flooding and damaging waves and FEMA-4442-DR for severe spring weather and flooding were declared within the last 18 months. We deeply appreciate the federal assistance you authorized to help four tribal nations and 52 counties recover from \$92,000,000 of damage caused by those two incidents, as well as the coronavirus relief. Minnesota also has a state-funded program that provides public disaster assistance when federal aid is unavailable. We are currently recovering from 15 open state disasters that will draw around \$23,000,000 from our state disaster account to help an additional 66 counties and two tribal governments.

The challenge of recovering from these fires, concurrent with the numerous natural disasters, is made even more difficult by the negative economic conditions triggered by the COVID-19 pandemic. In February, Minnesota had a projected state budget revenue surplus of \$1.5 billion. We now face a \$2.4 billion projected revenue deficit, a negative swing of nearly \$4 billion.

Disaster assistance under the Stafford Act is clearly warranted. Without it, and given the already heavy burden of so many previous state and federal disasters and the COVID-19 response, Minnesotans will struggle to return their communities to normalcy.
