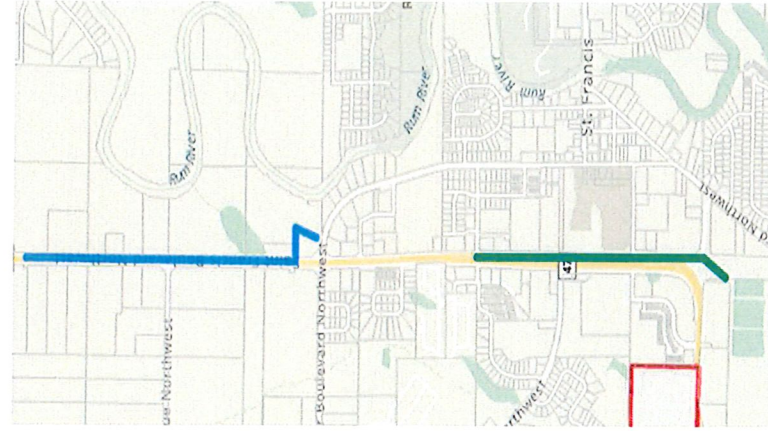


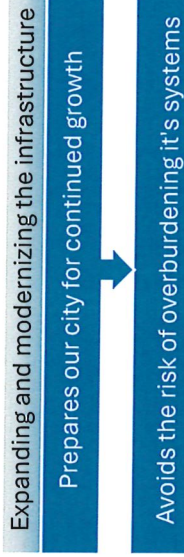
THE CITY OF ST. FRANCIS REPLACEMENT AND EXPANSION OF TRUNK WATER & WASTEWATER FACILITY LINES

"A City of Progress, Pride and Possibilities"



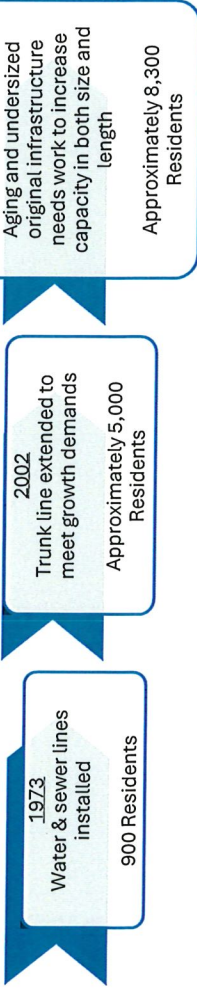
The City of St. Francis is requesting assistance on the replacement and expansion of trunk water and wastewater facility lines. St. Francis is a city of 8,300 residents on the northern edge of Anoka County. Our cities facilities were constructed in the 1970's including our main trunk lines that extend along the highway, with a population of roughly 900 residents.

Today, there is a total of 2,965 households in St. Francis. The portion of the trunk line that the city is requesting support for carries most of our services for residential, commercial and light industrial users, including water support for 344 fire hydrants.

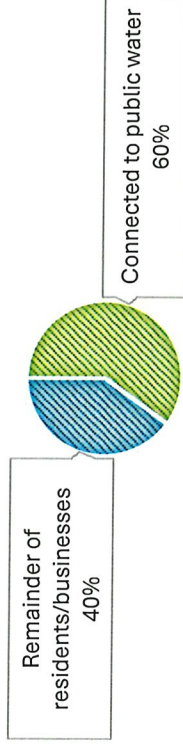


EXPANSION BENEFITS:

- Meeting future state and federal requirements

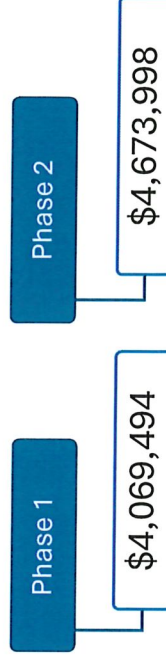


CURRENT USAGE



PROJECT TIMELINE

This project would occur before or at the time of a State Highway 47 reconstruction project. St. Francis can create efficiencies and save money to complete the underground work during a highway reconstruction project. The City has applied for various grants on behalf of this project to MnDOT to complete the pavement portion of the project, but those funds do not cover the added expense necessary for infrastructure.



With mobilization costs and inflation, it is the goal of the city to work to complete all the work in one project.

TOTAL COST: \$8,743,492

The City is prepared to secure a bond and utilize cash funds as needed for this project.

TOTAL REQUEST: \$3,000,000

Rate users include residential, education, industrial, commercial and retail uses.

Supporting our businesses with stability aids in ensuring residents and visitors have opportunities for a diverse commercial base that meets households needs and creates job opportunities. Our businesses provide goods and services to St. Francis residents as well as residents of the surrounding cities and townships. The commercial and retail base provides opportunities for child care, banking, groceries, restaurants, fuel stations, pharmaceutical needs, to name a few. In a 2022 market report, it was identified that there was a total population of 60,940 within a ten-mile radius. Additionally, we are continually working with housing providers to have a city that can offer a range of housing opportunities from multi-family, single family homes and senior living options.

It is important to us that the structure as well as the rates remain stable. If the local economy becomes difficult due to the infrastructure needs it will negatively impact the stability and future growth for our city. Federal assistance would aid in the success of the project that may otherwise directly and potentially negatively, impact residents, school districts and commercial users. We support the request for funding and thank you for the consideration.

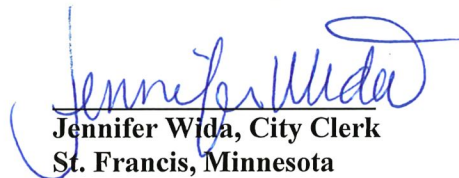

A RESOLUTION SUPPORTING A REQUEST FOR FEDERAL APPROPRIATIONS.

WHEREAS, The City of St. Francis has a project need to place the water and sewer lines from Cree Street to Ambassador Blvd in the City to address aging and undersized utility infrastructure that is essential to the prosperity of the community and surrounding area;

AND WHEREAS, to further support the water and sewer facilities in this area, there is a need to expand the existing utility lines to allow development connections through growth north of Ambassador Blvd in the City of St. Francis;

AND WHEREAS, project costs on the utility lines would have a greater efficiency and reduced cost if completed as one project before or during the proposed Hwy 47 reconstruction project currently in the planning phase by the Minnesota Department of Transportation working in partnership with the City of St. Francis;

AND WHEREAS, the provision of grant funds for the construction of water and sewer utility lines from Cree Street to Ambassador Blvd will have a regional impact in the orderly development of residential and commercial opportunities both in the City of St. Francis and surrounding communities;

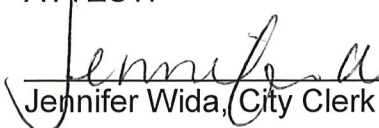
AND WHEREAS, an application was submitted to Representative Tom Emmer's office for federal assistance of 80% of the project costs hereto in March of 2024; and,

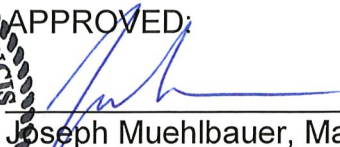

I am writing to express support for the City of St. Francis's request to receive Federal Assistance for a Utility Replacement and Expansion project. Without the assistance, project costs weigh heavily on rate users that impact not only residents of St. Francis but directly includes part of the Oak Grove community.

The City of Oak Grove is under contract with St. Francis for both water and sewer services to serve a neighborhood on our northern border. Currently 220 Oak Grove households are on the St. Francis system with expansion space for 40 more. It is important to us that the rates from St. Francis remain reasonable as there is a direct impact to our residents.

Increased rates put pressures not only on our residents but impact the school district levy in which our residents are part of. Additionally, residents in Oak Grove utilize many of the commercial and retail services in St. Francis. As the city owns and operates their infrastructure there is a smaller base in which project costs are shared related to infrastructure needs. The St. Francis Area School District is writing to express support for the City of St. Francis to receive Federal Assistance for a water/wastewater replacement and expansion project. Without the assistance, project costs weigh heavily on rate users, such as the School District, which is then passed along to the families that are within our district boundaries.

St. Francis Area Schools serves about 4,000 students and expands over or into nine cities and townships. The district has several buildings within the City of St. Francis water and sewer boundaries including an elementary school, learning center, middle school, high school and district offices. Our school boundaries include households in St. Francis and a majority of the Anoka County 6th Congressional District, including Oak Grove, Bethel and East Bethel.
