Significant growth in all these communities as well as communities south and east has caused concerns for worsening safety conditions for our residents commuting daily through County 19. Upgrades are needed to the County 19 intersections with Hennepin County 117/203 next to the regional Crow Hassan Park, and at the nearby intersection with Hennepin County 123. Solutions have been identified by engineers including roundabouts at each intersection, but funding is not available through the County or other sources for the necessary improvements.

I support the City of Hanover's application for Community Project Funding through the House of Representatives and appreciate your support in helping to get this project completed.
