**Project Description Process**: Anoka County provides several opportunities to provide comments, feedback, and concerns to the project development team. We utilize public open houses, one-on-one business and resident meetings, websites, and virtual open house platforms. Additionally, the public and community can provide comments, concerns, and feedback on the project via email, phone, and letter formats.

**Project Phase (e.g., Planning, Final Design, Construction):** The project is currently in the environmental analysis and preliminary design stage of the project. The project includes the construction of one additional travel lane in both directions along US Hwy 10 to help address congestion along the corridor and is not a full reconstruction project.

NEPA Category of Action (e.g., Categorical Exclusion, Environmental Assessment, Environmental Impact Statement): We are currently working with FHWA and MnDOT to determine if the project can follow the Categorical Exclusion process or the Environmental

Assessment (EA) path. Based upon the nature of the work and forecasted project impacts, we do not expect this project to need a full Environmental Impact Statement (EIS).

Status of Environmental Review: We have started portions of the environmental review but have not completed it due to no committed sources of construction funding.

Whether the project has received Federal funding previously, and if so the source and amount: No, this project has not received federal funding to-date.

On behalf of our entire Board, thank you for considering this request. The funding for this project will save lives and allow for expanded capacity for critical commerce to the region.

Re: Support of Anoka County's Trunk Highway Bond Request for U.S. Highway 10 Strategic Congestion Mitigation to Extend Six Lanes through the City of Coon Rapids

Dear Governor Walz,

I am writing to express my strong support for Anoka County's Trunk Highway Bond Request for the proposed U.S. Highway 10 Strategic Congestion Mitigation Project.

US Highway 10 is part of a major travel corridor for commerce and commuters between the Twin Cities and St. Cloud, as well as to Greater Minnesota. A recent traffic study indicates this highway segment operates at poor levels of service, with severe congestion, during peak morning and evening rush hours.

As part of the Greater Minnesota Gateway coalition of local governments, the City of Coon Rapids is aware that Anoka County is actively pursuing funding to improve safety and congestion on the 3.2 mile section of U.S. Highway 10 between Hanson Boulevard (CSAH 78) and Round Lake Boulevard (CSAH 9). Traffic concerns are a result of the roadway narrowing from six lanes to four at the Hanson Boulevard interchange.

In addition, major, multi-year construction will be occurring along the Highway 10 corridor in the City of Anoka beginning in 2022. The expansion of U.S. Highway 10 from Hanson Boulevard to Round Lake Boulevard would allow northbound vehicles to exit at Round Lake Boulevard, alleviating significant backups and longer travel times during future corridor reconstruction. The existing interchange bridges (Hanson Boulevard, Main Street, Northdale Boulevard, and Round Lake Boulevard) and roadways within Coon Rapids were designed to facilitate the expansion.

As the proposed project falls within our City and as a community in Anoka County, the City of Coon Rapids supports the County's efforts to pursue funding through various federal and state transportation programs.





The City of Ramsey is pleased to support the Highway 10 Strategic Congestion Mitigation Project in the City of Coon Rapids as part of the area coalition known as the Greater Minnesota Gateway. The North Metro Mayor's Association (NMMA) is aware that the movement of people, goods, and services in the north metro region are drastically impacted by intersections at Ramsey and Sunfish Lake Boulevards on Highway 10/169 in the City of Ramsey. NMMA supports SF860 as a critically regionally significant need in the north metro.

The congestion negatively impacts businesses and residents in the cities of Anoka, Andover, Ramsey, Coon Rapids, the surrounding area, and ultimately the overall region and state economies.

The cities of Anoka, Andover, Ramsey and Coon Rapids are at the forefront of developing Highway 10/169 improvements, including elements from the Anoka Solution at Thurston Avenue, Fairoak Avenue, and Main Street. Dear Governor Walz:

I write to you today to ask for your support for a significant public safety and traffic congestion improvement project on U.S. Highway 10 from Hanson Boulevard to Round Lake Boulevard in Coon Rapids.

U.S. Highway 10 is part of a major travel corridor for businesses and commuters between the Twin Cities and St. Cloud, as well as to northern Minnesota. A recent traffic study conducted by the Minnesota Department of Transportation shows a total of 1,621 crashes on U.S. Highway 10 over the past 10 years. You can find more of MNDOT's findings at https://tinyurl.com/tyb2tth.

In addition, congestion on this corridor is impeding the development of the northern suburbs, hampering our local economy, and wasting the time of our residents. In 2019, the House Transportation Committee held hearings on the Highway 10 improvement project and several businesses testified that they had missed out on opportunities to expand or recruit new businesses due to poor state of Highway 10.

Anoka County has partnered with MNDOT to find the safest and most cost-efficient way to identify right-sized, fundable-scale projects, utilize existing infrastructure and consider less-traditional strategies that were not available ten years ago. Both the county and MNDOT have committed to engaging appropriate stakeholders and the public in this endeavor. House Transportation Committee Chair Frank Hornstein is also aware of these efforts.

I respectfully ask for your support of and advocacy for trunk highway bonds to help fund this crucial highway artery that thousands of Minnesotans across the state rely on.
